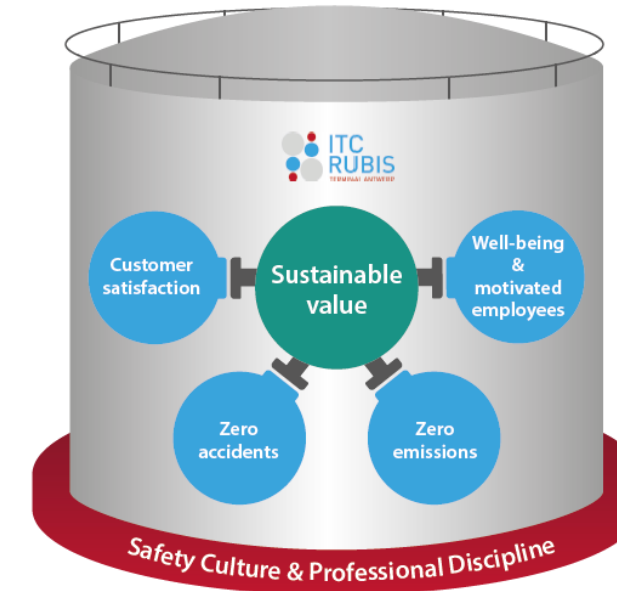
Our policy
